Our Year and Looking Ahead

Dear Valued Akamai Stakeholders,

The United Nations Environment Programme (UNEP)'s [Emissions Gap Report](#) for 2024 delivers a stark yet motivating message: While we've made notable progress in renewable energy deployment, the global dependence on fossil fuels continues to pose challenges to meeting the Paris Agreement's 1.5°C temperature goal. Simultaneously, the escalating frequency and severity of climate-related disasters have exposed vulnerabilities in energy systems that were not designed for the realities of a rapidly changing climate. This year, 2024, has underscored this urgency, with [record-breaking temperatures](#), extreme [weather events](#), and their profound socioeconomic impacts reinforcing the need for deep, rapid, and sustained reductions in global greenhouse gas emissions.



In the face of these challenges, 2024 has also been a year of transformation. A shift is gaining momentum: Companies, governments, and communities are increasingly moving beyond short-term fixes toward more holistic and impactful decarbonization strategies. Within corporate climate action, the discourse around [energy attribute certificates \(EACs\)](#) has evolved significantly. The growing emphasis on impact-driven renewable energy procurement has highlighted the importance of aligning energy purchases with real-world emissions reductions, creating a pathway for meaningful contributions to decarbonizing the global energy grid.

At Akamai, 2024 has been a year of action and progress. As a leader in cloud computing, cybersecurity, and content delivery, we have embraced our responsibility to be a driving force in the energy transition. Our global platform, a foundational part of the modern internet, is also a cornerstone of our sustainability strategy. Our work this year has reinforced our priority in aligning our growth with ambitious climate goals.

Here's a snapshot of our 2024 progress:

- **Net-Zero Emissions:** We continue to remain on track to achieve net-zero emissions by 2030 despite increases in our overall emissions output. In 2024, we implemented innovative emissions reduction strategies across our global operations, leveraging new partnerships and approaches to accelerate progress.
- **Build Efficiency:** We've optimized our data center infrastructure with cutting-edge hardware and software efficiencies, achieving 1.34% reduction in energy intensity across our network while increasing our capacity 25% year over year.
- **100% Renewable Energy:** This year, we expanded our renewable energy portfolio with impactful progress across North America, EMEA, and APAC, including a new project in the EU. These efforts have moved us closer to achieving 100% renewable energy by 2030 while driving real emissions reductions through the Emissions First approach.

- **Supplier Engagement:** We partnered with key suppliers to implement measurable sustainability goals, resulting in a collective 42% reduction in supply chain emissions this year alone.
- **Circularity:** Our circularity initiatives reached new heights in 2024, with 100% of our retired IT equipment being repurposed or recycled responsibly through e-Stewards-certified programs.

Looking ahead, 2025 is not just another year — it's an opportunity to amplify our impact. We are doubling down on integrating sustainability into every facet of our operations, and inspiring our partners and peers to do the same. Collaboration remains at the heart of this journey. Whether through advancing renewable energy in underserved regions, innovating in carbon removal technologies, or supporting our customers' sustainability goals, Akamai is in pursuit of building a resilient, socially responsible, and sustainable future.

The progress we've achieved in 2024 is not the end of our journey but a powerful reminder of what's possible when purpose meets action. Together, we can redefine what's achievable for our industry, our planet, and future generations.


Taking measured, impactful action on climate change is not only a global imperative but also a business-critical priority for driving sustainable growth and resilience. To fulfill this ambition, we have crafted our net-zero targets and strategy in alignment with ambitious climate pathways, such as the IPCC's Representative Concentration Pathway (RCP) 1.9, which charts the course for limiting global warming to 1.5°C.

As a global leader in distributed computing, Akamai provides critical services in cloud computing, security, and content delivery, across large-scale networks consisting of servers, switches, routers, and other network devices. To ensure we accurately track our emissions impact, we are continuing to use the current [World Resources Institute \(WRI\) Greenhouse Gas \(GHG\) Protocol](#), the most widely recognized global standard for comprehensive and consistent emissions measurement and management.



Our sustainability program is built on best-in-class climate and greenhouse gas emissions data, driving informed and effective decisions on emissions reductions, renewable energy procurement, carbon offsets, stakeholder engagement, and other strategic initiatives — all of which reflect our dedication to accountability, community, and trust.

Affirmation of Our 2030 Goals

In 2024, we made significant progress to scale our cloud computing business and provide new [services](#) and [points of presence](#) for our customers. As we forecasted, this build out increased our overall electricity consumption and emissions output. Despite this growth, we remain on track and dedicated to achieve net-zero emissions across our global data center and office footprint by 2030.

As sustainability is a multifaceted issue, we recognize various paths to achieving our objectives. As a founding member of the [Emissions First Partnership](#), our goal is to accelerate grid decarbonization and maximize emissions reduction impacts while ensuring grid stability. We recognize that our journey to net-zero will not always be linear.

As we scale our business, we remain aware of the environmental cost that comes with growth. We are more emissions-focused than ever and strive to provide stakeholders with a clear view of our impact and progress. This includes prioritizing emissionality¹, system-level engagement, and staying on course with our purpose-built strategy that emphasizes long-term, measurable progress, rather than relying on annual offsets, which may only reflect short-term adjustments without authentic emissions reduction. From the inception of the Akamai corporate sustainability program in 2009, we have remained aligned in pursuing our objectives with integrity and tenacity, and we will continue to do so as we move forward.

During 2024, we continued to invest in purchaser-caused² renewable energy projects in emissions-intense markets that help strengthen [our renewable energy portfolio](#), contribute to our net-zero goal, drive positive impacts in surrounding communities and ecosystems, and directly support our growth in energy consumption. Recognizing the scale at which we operate and the need for system-wide efforts, we also leveraged our global positioning to engage in [public policy advocacy efforts](#) and collaborate within [industry groups](#).

¹Emissionality, a term coined by [WattTime](#), is the strategy of identifying the best locations for new renewable energy and choosing projects that maximize beneficial climate impact as measured by their avoided emissions.

²Purchaser-caused refers to the concept where a company's purchase of renewable energy directly contributes to the creation of new renewable energy projects and the associated energy attribute certificates (EACs)

We are constantly seeking new opportunities to meet the evolving needs of our global platform both presently and in the future. Through 2025, we plan to make further strides toward our objectives by procuring additional renewable energy from responsible sources globally, investing in projects that create and deliver new renewable energy, and implementing credible measures to mitigate and remove carbon emissions across our global platform.

Our Philosophy on 1.5°C

In 2024, Akamai deepened our focus on sustainability by aligning our cloud computing services, security, and delivery operations with our climate scenarios across key metros globally, in conjunction with our broader 2030 corporate sustainability goals. Building upon our 2023 advancements, we further integrated our Infrastructure as a Service (IaaS) — our cloud computing business — into our sustainability framework, underscoring our pathway to achieving a 1.5°C future.

Akamai's [Emissions First approach](#) serves as the foundation of our approach of addressing climate impact and building a resilient business model. We are prioritizing direct, measurable emissions reductions across our global operations and infrastructure, and it reflects our dedication to sustainability that scales with Akamai's growth. Our pathway toward achieving net-zero by 2030 incorporates a series of adaptation and resilience measures tailored to meet the unique challenges of our expansive network.

[Our revised pathway approach](#) leverages insights from the IPCC's Representative Concentration Pathways (RCPs), with a strategic emphasis on RCP 1.9 and 2.6, which are essential to limit global warming to 1.5°C. Akamai's roadmap incorporates robust adaptation strategies across our global footprint, particularly in climate-vulnerable regions where data center resilience, energy efficiency, and renewable energy integration are imperative.

In response to evolving standards and the unique complexities of aligning our decentralized global network with the Science Based Targets initiative (SBTi), Akamai has decided [not to pursue SBTi target setting](#). We believe that our approach to transparent, robust annual reporting through [CDP disclosures](#) provides a comprehensive view of our emissions reduction progress and target achievements. By leveraging these disclosures, along with our adherence to strategy and governance principles such as those found in our [Task Force on Climate-related Financial Disclosures \(TCFD\)](#) and in the future with our [International Financial Reporting Standards \(IFRS\) S1 and S2](#) disclosure, we are building a foundation that will keep stakeholders well-informed about our ongoing sustainability performance and adaptation to emerging standards.

Additionally, our support of [The Climate Pledge](#) reinforces our dedication to achieving net-zero emissions. We view this strategic alignment as a powerful framework that complements our existing reporting, allowing us to continue building a resilient, forward-looking sustainability program without

relying solely on the SBTi. Through this approach, Akamai remains steadfast in our pursuit of impactful emissions reductions that are both measurable and aligned with global climate goals.

Akamai's climate resilience strategy is integral to our broader pathway toward a 1.5°C-aligned future. As our organization continues to expand, we remain focused on embedding sustainability across the company, ensuring that our operations not only progress toward net-zero goals but also build the resilience necessary to thrive in a carbon-constrained world. This holistic approach underscores Akamai's role as an industry leader in sustainability, setting a course that aligns with the latest climate science and international standards.

Akamai Cloud Computing

[Akamai cloud computing](#) is a cloud-based IaaS platform and a broad set of distributed cloud and edge computing services to help businesses build, deploy, and manage applications and workloads on the world's most distributed network. It offers various services, including computing, storage, and networking, that enable enterprises to scale their operations and infrastructure as needed. Our platform is designed for high-performance computing, with low latency and high-speed connectivity to the internet, with sustainability in mind.

By leveraging Akamai's cloud, businesses can reduce their carbon footprint by minimizing the need for on-premises IT infrastructure and reducing energy consumption by serving content closer to the end users, therefore reducing the network infrastructure and power required. We are dedicated to sustainability and reducing our carbon footprint by utilizing renewable energy sources like wind and solar. By leveraging the power of Akamai cloud computing, businesses can enhance their operational efficiency, reduce costs, and play an active role in global sustainability efforts with an emissions-first approach.

As we anticipate continued growth for our global platform in the coming years, we are taking a comprehensive approach to evaluating and addressing any potential environmental impact and power consumption concerns. With Akamai cloud computing fully integrated into our sustainability goals, we have established strategies with an emissions-first approach as well as incorporated our cloud computing business into our [IPCC RCP revised pathway approach](#) that aligns with our alignment to corporate sustainability while supporting the growth of this emerging business segment.

As we continue to expand the Akamai cloud computing platform, we are concurrently maintaining our classic cloud sites while we merge the two platforms. To ensure that we keep an accurate record of our

emissions impact for what remains of our classic cloud sites, we will continue to report the emissions impact separately for the foreseeable future.

Real-Time Emissions Accounting

Real-Time Network Power Consumption

Akamai's widely distributed footprint brings complexities that can make tracking energy consumption difficult due to sometimes-limited data provided by our data center partners. To tackle this challenge, we have developed a database infrastructure that connects with Akamai's proprietary data collection system, which collects five-minute-interval server power draw statistics from Akamai-engineered servers and network hardware.

This data is captured and measured against the theoretical maximum power values as tested in Akamai's hardware labs under various conditions, to ensure we accurately account for our energy consumption and emissions impact across our global deployments. We use interval-level data to ensure that electricity consumption is fully and accurately captured within the defined reporting period, reflecting our true operational energy use.

Akamai's power collection process enhances power monitoring, ensures precise data collection, and strengthens our ability to identify and implement efficiency improvements across our global network footprint.

Utilizing Real-Time Emissions Data

In tandem with our power collection, Akamai has integrated real-time emissions data from WattTime and REsurety to enhance the accuracy of our emissions measurement and drive forward efficiency and sustainability initiatives. By leveraging these data sources, Akamai can monitor and manage the carbon emissions associated with our global operations more effectively.

- **WattTime Integration:** WattTime provides real-time marginal emissions data, enabling Akamai to assess the environmental impact of our energy consumption across various locations and times. This information allows Akamai to optimize our operations by scheduling energy-intensive tasks during periods when cleaner energy sources are predominant, thereby reducing overall carbon emissions.
- **REsurety Collaboration:** Through REsurety's [Locational Marginal Emissions \(LME\) data](#), Akamai gains detailed insights into the carbon intensity of electricity at specific grid locations. This granular information empowers Akamai to make strategic, data-driven decisions on energy procurement and consumption, optimizing operations to align with our sustainability goals and reduce carbon impact.



Strategic Implementation

- **Operational Optimization:** By accessing real-time emissions data, Akamai can get a more detailed understanding of our operational impact, focused on the specific time and location where renewable energy is more widely available.
- **Informed Decision-Making:** The detailed emissions insights from WattTime and REsurety empower Akamai to make strategic choices in energy procurement, focusing on sources that offer the lowest carbon footprint and have the highest impact of carbon abatement.
- **Enhanced Reporting:** Incorporating precise emissions data into our reporting mechanisms allows Akamai to transparently communicate our environmental impact and progress toward sustainability targets to stakeholders.

By integrating real-time emissions data from WattTime and REsurety, Akamai is showcasing our approach to environmental stewardship, harnessing advanced analytics to achieve impactful emissions reductions across our global operations.

Operating in Colocation Spaces


We take a comprehensive approach to understanding our emissions footprint. Like many companies in the [IT Software and Services](#) space, our colocation data center footprint constitutes a significant portion of our global operations.

Our sustainability program focuses on addressing energy consumption and emissions across our infrastructure, both direct and indirect. This includes energy use from owned generators, cooling equipment, and IT equipment in data centers. Our 2030 sustainability goals underscore our aspirations, targeting net-zero emissions and 100% renewable energy for our global platform. To achieve this, we collaborate closely with our colocation partners to advocate for the procurement of high-quality renewable and clean energy attributes.

While we prioritize reducing emissions within our direct operational control, we recognize the importance of critical services in colocation data centers, including cooling, lighting, and uninterruptible power supplies (UPS). These services contribute significantly to overall energy use, often reflected in metrics such as Power Usage Effectiveness (PUE). While contractual terms with vendors may limit our ability to directly influence utility energy mix, site efficiency, and PUE metrics we remain engaged in working collaboratively with our partners. Our efforts are focused on addressing energy consumption and emissions associated with colocation operations and PUE, in alignment with our 2030 sustainability objectives.

As we advance, we remain steadfast in our approach to further decarbonizing our services and expanding our focus to address broader impacts across our value chain, driving progress toward a net-zero future.

Our 2024 Approach to Operational Emissions Accounting



Standardizing GHG Accounting in Colocation Spaces

In 2025, Akamai will continue to partner with our colocation service providers to establish standardized accounting and reporting practices for emissions disclosures in our data center locations.

Standardized emissions accounting that provides an approach to consequential traceability is crucial to ensuring accurate and consistent reporting, preventing issues such as double-counting or failing to report emissions values entirely due to assumptions that either providers or customers have accounted for. This effort is particularly critical as data center power demands continue to grow, amplifying the need for clarity and alignment in emissions reporting.

What are the Key Objectives?

- Ensuring our partners prepare GHG inventories that represent a true and fair account of their emissions by using standardized approaches and principles.
- Increasing consistency and transparency in GHG accounting and reporting across organizations and programs.³

³ Both objectives are foundational principles derived from the [Greenhouse Gas Protocol \(GHGP\)](#).

Despite these objectives, Akamai, as a global customer of colocation services, frequently encounters significant variations in how colocation providers interpret and implement the current Greenhouse Gas Protocol (GHGP), the primary accounting guidance used by most companies today.

Even among providers with similar contract structures and power delivery models, reporting practices differ considerably. This variability in reporting practices poses challenges to the goal of standardizing GHG accounting, making it more difficult to track emissions accurately and achieve seamless industry-wide comparability. While the GHGP offers a valuable foundation, it can be challenging for global companies to derive consistent and actionable data across jurisdictions.

Key Challenges in Emissions Reporting

A central challenge in GHG emissions reporting for colocation services lies in determining which party is responsible for reporting specific emissions and under what boundary. In particular:

- **Indirect Energy Emissions Reporting:** Some colocation providers include all emissions from energy consumed within their data centers as indirect emissions, encompassing power used by their customers.
- **Indirect Energy Emissions vs. Value Chain Emissions:** Other providers only account for emissions related to their infrastructure as indirect energy emissions, leaving customer-related emissions unaccounted for or assumed to fall under value chain emissions.
- **Common Areas Only:** A few providers report only the emissions associated with ancillary power used in shared or common areas, such as lighting or cooling, creating further inconsistencies.

Variations in reporting frameworks can lead to challenges for both customers and providers in achieving clarity and consistency, potentially impacting the accuracy and reliability of emissions data and alignment with global sustainability goals. Establishing clear standards would effectively minimize the risk of misreporting or omissions, fostering greater trust and transparency in GHG disclosures.

Akamai's Approach to Clarifying Accountability

To address these issues, Akamai is aligned on clarifying the interpretation of operational control in colocation spaces. This approach will assign emissions responsibility based on operational authority, which governs the activities and decisions impacting emissions. We aim to work across the industry to establish clearer boundaries for:

- 1) **Provider Responsibility:** Emissions associated with the provider's infrastructure, including building operations, cooling systems, and power delivery infrastructure.
- 2) **Customer Responsibility:** Emissions tied to customer usage of colocation space, such as the energy powering servers.
- 3) **Data Transparency:** Ensuring providers consistently share accurate and granular energy and emissions data with customers to support transparent reporting and informed decision-making.

Moving Toward Industry Alignment

Akamai is supportive in fostering collaboration between colocation service providers and their customers to establish clear and consistent accounting practices. By working together to standardize the various approaches, we can enhance the accuracy of emissions reporting and unlock broader

opportunities for meaningful decarbonization. Addressing reporting challenges will enable the data center colocation industry to focus on driving impactful initiatives, such as:

- Expanding investments in renewable energy generation
- Advancing clean energy procurement strategies
- Innovating in energy efficiency and operational sustainability

Through these collective efforts, we strive to bridge gaps in emissions reporting, provide more granularity through our accounting, and inspire progress by promoting transparency and accountability across the colocation and data center ecosystem. We believe working together as partners, we can help lead the way toward a more sustainable future.

Incorporating Best Practices with CEBA

In partnership with [CEBA](#), we have prioritized integrating environmental considerations into the strategic planning process for our global platform. Through our participation in CEBA, Akamai helped to create a guide of best practices for corporate colocation and cloud procurement, and calls for our colocation providers to follow the same principles.



As a signatory of [the Corporate Colocation and Cloud Buyers' Principles](#), Akamai supports the following goals:

- 1) **Options:** Provide options for cost-competitive services powered by renewable resources that reduce emissions beyond business as usual.
- 2) **Data:** Deliver monthly data on the colocation customer's direct and indirect energy consumption, water consumption, greenhouse gas emissions, and other environmental data.
- 3) **Incentives:** Align the partnership between customer and service provider, so both parties have an incentive to reduce energy consumption.
- 4) **Collaboration:** Provide options for customer collaboration on efficiency and renewable energy enhancements.
- 5) **Disclosure:** Disclose data for individual sites and total global corporate footprint, as well as site-specific energy sources.
- 6) **Advocacy:** Engage in policy advocacy efforts that support the use of renewable energy.

Helping to ensure our colocation and cloud service providers support these principles will help not only Akamai, but also other companies using their services, to meet sustainability goals.

Biodiversity and Emissions Impact

Understanding Akamai's Biodiversity Impact and Challenges

Akamai recognizes the crucial importance of addressing biodiversity as part of our environmental impact, and integrating nature-positive practices across our operations and emissions reduction

activities. As part of Akamai's environmental management system (EMS), our alignment with ISO 14001, we are regularly evaluating the company's environmental aspects and impacts to inform our targets and initiatives.

Akamai's environmental aspects related to biodiversity include:

- Consuming power across our global operations
- Purchasing and disposing of hardware
- Housing, maintaining, and operating our network equipment

Although we do not manufacture the hardware used across our platform and our operations are currently primarily in multi-tenant data center spaces, we recognize the potential for future expansion into wholly operated and owned data center environments. Regardless of the operational model, we aspire to make a tangible impact in mitigating biodiversity impacts as we work toward a decarbonized future. Through collaboration, innovation, and strategic initiatives, we aim to address environmental challenges while continuing to grow responsibly.

The repercussions on biodiversity are varied and could manifest in unpredictable ways on a global scale for ecosystems, public health, infrastructure, and our operations. This interconnected challenge is compounded by the impacts of climate change, where higher [Representative Concentration Pathway \(RCP\) scenarios](#) lead to more frequent and severe risks to our supply chain and the communities in which we live, work, and serve. Aligning our strategies with ambitious pathways like RCP 1.9 or 2.6, which limits global warming to 1.5°C, is essential to mitigating these effects and achieving long-term resilience.

Our Nature-Positive Practices

We are embracing nature-positive practices and decarbonization activities across our value chain, with a focus on renewable energy usage, sustainable waste management, and partnership with environmentally responsible suppliers.

Energy Use

- We are prioritizing our efforts to power our data centers and offices with [100% renewable energy](#) sources to reduce the emissions footprint and associated impacts on biodiversity.
- We strive to implement [energy efficiency](#) measures to minimize resource use.

Waste Management

- We ensure the adoption of sustainable waste management practices such as e-Stewards, including [recycling 100% of our electronic waste](#) and materials, to prevent pollution and habitat degradation.

Supplier Engagement

- Through our [supplier engagement](#) programs, we embed biodiversity into the planning of new build data centers by selecting sites with low ecological sensitivity and sourcing from partners who align with environmental responsibility.

To guide our endeavors in safeguarding and enriching biodiversity, we have developed a [biodiversity policy](#), which we will consistently review and enhance to align with progressive practices, our EMS, and our global sustainability objectives. We will continue to report comprehensively on progress toward our objectives and our environmental risk and opportunity management, expanding focus to include interconnected risks and opportunities, such as biodiversity, as we transition in the future to align with the IFRS S1 and S2 guidance.

Quantifying Health and Ecosystem Benefits of Renewable Energy


We recognize that the impact potential of renewable energy project investment goes beyond delivering clean electrons to the grid. In 2024, Akamai partnered with [Quantum Energy](#) to analyze the grid-level changes in generation due to the electricity produced by Akamai's wind and solar projects in the U.S. and the avoided emissions to air, soil, marine, and freshwater, which are mapped to epidemiological damage pathways to assess public health and ecosystem impacts. The location of new clean energy projects can be optimized to avoid carbon, terrestrial acidification, freshwater eutrophication, photochemical oxidants (ecosystems), land saved by reduced fuel extraction, water depletion, terrestrial ecotoxicity, and freshwater ecotoxicity, among other factors, to increase biodiversity benefits as a result. **We are proud to highlight that 0.41 species** were saved, measured using the industry-standard Potentially Disappeared Fraction of Species metric, as a result of Akamai's 2024 renewable energy portfolio impact.



Making impact-driven and holistic sustainability progress is crucial for Akamai's long-term business resilience, and for the health of our planet and the interconnected ecosystems, species, and people that inhabit it.

Embodied Emissions Program

As part of our EMS and the continuous improvement of our sustainability program, we are further developing our embodied emissions program. Now part of our operational efficiency lifecycle, the program is being explored under strategy & architecture and implementation phases, as seen in the graphic.



As part of our net-zero targets and broader sustainability goal, Akamai is dedicated to exploring collaborative methods to reduce the embodied carbon emissions within our supply chain supporting our global platform. We recognize the urgency of this issue and are working on a comprehensive approach encompassing several critical stages toward achieving our goal.

1. Work toward enhancing transparency and traceability across the Akamai supply chain. We are in pursuit of fostering a collaborative relationship with our suppliers to gain deeper insights into their emissions impact and explore opportunities to reduce their environmental footprint.
2. Seek ways to incorporate low-carbon materials and technologies into our network. We are investigating alternative materials and energy-efficient technologies that can assist us in reducing the embodied emissions linked with the physical footprint of our global platform.
3. Implement sustainable practices across our operations, such as reducing waste, conserving energy, and promoting sustainable options for our global platform.
4. Connect with our industry partners and stakeholders to promote best practices in sustainable supply chain management and advocate for policies supporting a low-carbon economy for our global platform.

We intend to continue to engage with the [Clean Energy Buyers Institute \(CEBI\)](#) in the [Decarbonizing Industrial Supply Chain Energy \(DISC-e\)](#) program as part of our embodied emissions program.



In our annual emissions reporting, we are prioritizing accuracy to measuring and reducing our embodied carbon footprint. Our current focus has been calculating the embodied carbon emissions from our hardware and component purchases for our global platform. However, we acknowledge there is room for improvement and validation when measuring specific embodied emissions. We recognize the impact of purchasing capital goods over their useful life on our emissions output and remain dedicated to working with the industry to achieve greater accuracy in our calculations.



We aim to power Akamai's global operations with 100% renewable energy. To achieve this, we will continue strategically investing in purchaser-caused renewable energy, such as power purchase agreements (PPA) or virtual power purchase agreements (VPPA). We aim to add net-new renewable energy to the grid whenever possible, and obtain bundled and traceable renewable energy credits to align against our operations.

Due to the global footprint of our platform, we must rely on energy sources worldwide, including in regions where renewable energy isn't always reliable or readily accessible. Where we can't source purchaser-caused renewable energy or work directly with our colocation partners, we intend to procure renewable power as close to our operations as possible through meaningful utility, supplier, or other market-based options that provide reliable traceability of Energy Attribute Certificates (EACs), such as [Green-e certification](#) or those that meet local mandatory compliance standards.



Akamai Electricity Portfolio by Metro




US Renewables Update

In 2024, Akamai continued to advance our goal of 100% renewable energy and net-zero emissions. Building on progress made in 2023, Akamai, in collaboration with Teradyne and Wayfair, signed a [virtual power purchase agreement \(VPPA\)](#) to support the development of new renewable energy in Champaign County, Illinois, within the carbon-intensive grid of the Midcontinent Independent System Operator (MISO) North region.

This partnership reflects our emissions-first approach, which prioritizes reducing emissions in the regions that need it most. We expanded our 30 MW portion of Prairie solar to a 44.8 MW share of the project. Our portion of Prairie Solar is anticipated to generate approximately 100,177 MWh annually and prevent an estimated 77,000 metric tonnes of CO₂e emissions each year. Scheduled to come online in Q1 2026, Prairie Solar will benefit the environment, support job creation, and reduce the emissions impact on the local community, while adding significant renewable power to Akamai's U.S. portfolio.

Looking ahead to the 2nd half of 2025 and beyond, this project exemplifies Akamai's goal of driving meaningful climate action and supporting a decarbonized future through targeted, impactful renewable energy investments.



Global Renewable Energy Expansion

In 2024, Akamai focused on identifying opportunities to expand our renewable energy program globally, aligning with our dedication to bring net-new renewable energy to the regions where we operate. Through engagement with developers, market research, and targeted initiatives, we explored ways to advance renewable energy adoption across key markets, including the European Union (EU), India, Southeast Asia, Australia, and Japan.

Evaluating Projects in the EU

The EU remains a critical area of focus for Akamai, where we are actively exploring opportunities to add new renewable energy capacity. In 2024, we initiated a request for proposals (RFP) and [project-specific negotiations](#) centered on renewables that address carbon-intensive grids within the region. By engaging with developers and evaluating project options, we aim to align our renewable energy investments with the EU's ambitious climate targets while prioritizing high-impact opportunities that reduce emissions.

Exploring Opportunities in Asia-Pacific

In 2024, we laid the groundwork for our market-entry strategies in Japan, Singapore, and Australia. At the same time, we deepened our engagement with India's booming digital economy and Southeast Asia's vibrant energy markets — each offering significant potential for renewable-energy growth. Across all these regions, we focused on navigating complex regulatory landscapes and forging partnerships to drive forward solar and wind project opportunities.

By prioritizing areas with higher carbon intensity, Akamai is assessing the feasibility of projects that could bring new renewable energy capacity to local grids, contributing to emissions reductions and environmental benefits. These efforts aim to align with local and national sustainability goals while laying the groundwork for future investments that maximize both environmental and community impact.

Identifying Pathways in Japan

Japan's unique energy landscape, characterized by a reliance on imported fossil fuels, underscores the need for renewable energy development. Akamai sought opportunities to [collaborate with stakeholders](#) and evaluate potential projects, particularly in solar and offshore wind. By focusing on initiatives that align with Japan's carbon neutrality goals, we aim to contribute meaningfully to the country's clean energy transition.


Looking Ahead

As we look to 2025, Akamai is focused on transforming opportunities into impactful action to expand our renewable energy footprint. By prioritizing high-carbon-intensity regions and collaborating with local stakeholders, we aim to drive meaningful progress toward our sustainability goals.

Renewable Colocation Partnerships

We work closely with our data center partners, who share our environmental concerns, to ensure that our operations are powered solely by renewable energy sources. As of December 2024, around 95% of our network deployments are in facilities licensed or leased from our colocation partners, who have demonstrated a strong alignment to renewable energy. Our joint efforts have positively impacted the environment, and we continue to prioritize sustainability as a key objective in our operations.

In 2024 we saw a 11.8% increase over 2023 in the amount of renewable power used by our network. This was mainly due to increasing our deployments in data centers, which source renewable energy for 100% of the power they use. With our own renewable energy projects, Akamai has continued to see growth across our footprint through our direct EAC purchases, market-based utility supply, and certain attestation claims. We are proud to continue to make progress toward working with data centers to gain a greater mix of renewables and increased purchaser-caused supply in our energy mix to reduce our use of fossil fuels.

Contracting for renewable energy can be daunting. At Akamai, we strive to work closely with organizations like CEBA to provide comprehensive training programs for our colocation partners to encourage more procurement of renewable energy to power their facilities. [CEBA Boot Camps](#) are designed to provide an in-depth learning experience that can help members and supply chain partners navigate the complex energy markets and procurement solutions. Akamai's experienced industry experts led several training sessions throughout 2024, which were facilitated alongside CEBA staff.

Akamai's Clean Energy Impact

Locational Marginal Emissions

Measuring emissions displacement on a global scale is challenging, mainly because the amount of carbon emissions that a given megawatt-hour (MWh) of clean energy avoids varies widely, even across projects within the same region. To build on our emissions-first approach in 2024, we continued integrating [Locational Marginal Emissions \(LMEs\)](#) into our workstream from [REsurety](#) to track our emissions displacement activities more closely across our active purchaser-caused renewable portfolio.


Under the reporting provided by REsurety, LMEs are an innovative way to measure the metric tonnes of carbon emissions displaced by 1 MWh of clean energy added to the grid at a specific location at one particular time. LMEs are calculated at each power system node like the [Locational Marginal Prices \(LMPs\)](#) used to set wholesale electricity market prices. LMEs measure emissions by identifying the marginal generators that would have been producing energy if not for the renewable injection to the grid at that location.

The LME data that REsurety provides [enables Akamai](#) to calculate the estimated impact of our activities at each location on the grid. LME reports also offer visibility into specific emissions values abated for each MWh generated by our renewable energy projects. For example, they show how much gas or coal is displaced, or how much wind energy is curtailed, due to our activities. Utilizing this data allows us to increase the accuracy of our carbon accounting and analyze our renewable energy portfolio in a more real-time fashion. These reports also provide insight that helps Akamai evaluate new market opportunities and make strategic decisions on renewable energy procurement. Using LMEs ensures we focus on locations and technologies that can significantly impact our carbon emissions reduction efforts.

Akamai's Active Clean Energy Projects

Understanding our renewable abatement impact helps us to make meaningful progress toward our net-zero goals. With our ongoing incorporation of LMEs into our long-term approach, we can better understand the full impact of our renewable projects based on their hourly displacement over the 8,760 hours in a year. Getting to a highly precise measurement helps us track our progress and be more deliberate in reaching a net-zero future for Akamai.

Clean Energy Projects



The previous graphic highlights each project's total MWh production during 2024. It also includes two different emissions factors, including market-based emissions values based on the project location and generation profile and the LME values, which highlight a closer-to-reality market abatement.

Between the market-based emissions factor from the site location and LME values, we highlight the difference between the impact of each applied method. As we continue to form our emissions-first approach, we will look for ways to use innovative emissions abatement measurements, such as LMEs, across our global footprint.

Decarbonization Partnerships

ZEROgrid Initiative



Akamai continued to partner with the leading-companies in the [ZEROgrid Initiative](#), a collaborative initiative designed to accelerate the transition to a decarbonized, reliable grid by fostering partnerships among corporate energy buyers, grid

operators, policymakers, and researchers. The initiative focuses on leveraging corporate actions to address key challenges in grid reliability, decarbonization, and scalability while promoting innovative solutions and frameworks that benefit the energy ecosystem.

Through its Reliability Advisory Initiative (RAI), ZEROgrid facilitates proactive, high-impact discussions and actions to tackle emerging grid reliability challenges, particularly those arising from electrification, renewable integration, and dynamic load growth.

This past year, Akamai worked collectively as a part of the RAI to contribute to bridging the gap between grid operators (RTOs/ISOs) and corporations by creating a collaborative forum for two-way information sharing. The focus is on addressing resource adequacy, improving load forecasting, and supporting emerging clean energy technologies to ensure a resilient and cost-effective grid of the future.

Key Progress and Outcomes from RAI in 2024

Enhanced Two-Way Communication

- Goal: Foster open dialogue between corporates and RTOs/ISOs to align corporate energy strategies with grid reliability needs.
- Impact: Improved understanding of grid reliability mandates, corporate decarbonization goals, and actionable ways to align these efforts.

Proactive Planning for Load Growth

- Addressed challenges posed by rapid load growth from electrification (e.g., electric vehicles (EVs), data centers, manufacturing).
- Introduced scenario analysis frameworks to evaluate future demand variability, improving transmission planning and interconnection processes.

Integration of Emerging Technologies

- Promoted corporate-driven pilots for emerging clean technologies, such as virtual power plants, demand response systems, and grid-enhancing technologies.
- Supported the adoption of innovative solutions by providing evidence-based insights to grid operators.

Focus on Electrification and EV Load

- Collaborated with the U.S. Department of Energy to align EV charging infrastructure development with grid capacity.
- Highlighted the need for managed charging and vehicle-to-grid (V2G) technologies to enhance grid stability.

Corporate Playbook for Grid Reliability


The RAI developed a comprehensive playbook with actionable recommendations for corporations, focusing on:

- Supporting resource adequacy through flexible demand and ancillary services
- Increasing visibility into behind-the-meter (BTM) resources
- Addressing data-sharing challenges to enhance load forecasting

What Does the Future Hold for ZeroGRID?

The future of the ZEROgrid program is centered on fostering impactful corporate action to accelerate decarbonization, dynamic load management, infrastructure optimization, and collaborative planning. By promoting corporate investments in renewable energy and emerging technologies, ZEROgrid aims to drive substantial emissions reductions while supporting grid reliability. A strong emphasis on load flexibility, smoothing technologies, and emissions-informed planning will ensure that dynamic load management aligns with evolving grid needs. Infrastructure optimization efforts, including clean repowering and the adoption of grid-enhancing technologies, will address bottlenecks and support seamless renewable integration. Additionally, ZEROgrid will continue to champion two-way information sharing between corporates and grid operators, ensuring that planning strategies are collaboratively aligned to meet the demands of a sustainable energy future.

Emissions First Partnership

Akamai continues to work with the [Emissions First Partnership \(EFP\)](#), focused on accelerating global decarbonization. EFP companies are working to reduce our emissions from electricity use with impactful clean energy projects. Akamai believes putting emissions first will maximize our carbon reductions and enable us to have a more significant effect where we operate. Moving beyond [megawatt-hour matching](#) to focus on

the quantified emissions impact of electricity consumption and generation is at the heart of this approach. In 2024, the EFP made significant strides in refining emissions accounting and promoting effective decarbonization strategies. [\[88\]](#)

Key EFP Initiatives and Developments

Advancement of Emissions Accounting Principles

- The partnership emphasized the importance of recognizing that the emissions impact of a megawatt-hour of electricity consumption or generation varies based on time and location. [\[88\]](#)
- By prioritizing decarbonization, Emissions First aimed to provide stakeholders with confidence that emission reduction claims made by organizations are accurate and impactful.

Promotion of Consequential Emissions Impact Analysis

- Members advocated for the adoption of consequential emissions impact analysis to better understand the real-world effects of corporate renewable energy procurement.
- The approach continued to evolve on the actual emissions reductions achieved, rather than solely on the quantity of renewable energy purchased.

Engagement with Global Climate Initiatives

- The partnership actively participated in international discussions on climate action, aligning its principles with global efforts to reduce carbon emissions.
- By collaborating with other organizations and stakeholders, Emissions First contributed to the development of more accurate and impactful emissions accounting standards.

Educational Outreach and Thought Leadership

- Through its blog and publications, Emissions First provided insights into the evolving landscape of emissions reduction and clean energy solutions. [33]
- Topics covered included the climate and social benefits of relaxed market boundaries for low-income countries and the role of market boundaries in enhancing voluntary corporate renewable energy procurement. [34][35]

Looking Forward with Emissions First

By focusing on these areas, the Emissions First Partnership worked toward creating a more accurate and effective framework for corporate emissions accounting, ultimately supporting global efforts to combat climate change. Through continuous collaboration with policymakers, market leaders, and international climate initiatives, Emissions First seeks to influence the creation of policies and mechanisms that support high-impact corporate action. The partnership also aims to bridge gaps in global renewable energy accessibility, ensuring equitable contributions to emissions reductions, particularly in regions with emerging energy markets.





Developing Software Efficiencies

Akamai's continuous innovation in optimizing our edge server infrastructure is a significant step toward a more sustainable future. By focusing on smarter resource utilization and reducing hardware dependency, these efforts not only contribute to cost efficiencies but also deliver substantial environmental benefits. Below is a detailed analysis of the environmental impact and emissions reductions achieved through these efforts.

Software Example 1: Optimizing Disk Space

Akamai optimized our edge server software stack, enhancing disk utilization and enabling up to 12% additional caching capacity per server. This was achieved by:

- Reducing reserved disk space from 5% to 1%.
- Increasing disk utilization before managing cache data.
- Deploying these optimizations on Akamai's latest-generation hardware.

Environmental Impact

- **Reduced Hardware Demand:** Avoided the acquisition of 2,732 new servers.
- **Avoided CO₂ Emissions:** Approximately **78,000 metric tons (MT CO₂e)** projected reduction over five years — equivalent to taking over 16,900 cars off the road for one year.
- **Resource Efficiency:** Lower demand for disk production and transportation, contributing to reduced resource extraction and manufacturing emissions.

Software Example 2: Optimizing Capacity

By refining traffic load reporting, Akamai improved resource balancing across servers, preventing resource overload and increasing capacity by 10%–15%. Key outcomes include:

- Enhanced traffic capacity and added 3.6 Tbps (8.05%) of capacity without additional hardware.
- Reduced hardware needs and saved the deployment of 1,334 servers, with 218 servers avoided in Q4 '24 alone.

Environmental Impact

- **Avoided CO₂ Emissions:** Approximately **19,000 metric tons (MT CO₂e)** projected reduction over five years.
- **Energy Savings:** Fewer servers translate to reduced energy consumption for operations and cooling in data centers.
- **Supply Chain Efficiency:** Decreased demand for server manufacturing and shipping.

Environmental Benefits

Across both initiatives, Akamai projects a total **97,000 metric tons (MT CO₂e)** reduction in emissions over the next five years. This is equivalent to:

- Powering over 11,000 homes for one year
- The carbon sequestered by over 1.6 million tree seedlings grown for 10 years

These efforts align with Akamai's broader focus on sustainability by:

- Extending the lifecycle of existing hardware
- Minimizing the need for new resource extraction
- Reducing the carbon footprint of our delivery network

Developing Hardware Efficiencies

Akamai's server fleet is a cornerstone of our network, ensuring security, speed, and reliability for customers worldwide. This study set out to answer a key question: Have our server generations become more efficient over time?

To explore this, we analyzed real-time data snapshots from two primary types of production network servers. For clarity, we refer to these as our **Encryption-Focused (EF)** and **Data Transfer Optimized (DTO)** networks. Each server type plays a distinct role within our infrastructure:

- **EF** servers perform intensive cryptographic computations, consuming more CPU and power per megabit of data output.
- **DTO** servers operate with fewer computational overheads, offering another perspective on efficiency.

The study focused on four of Akamai's latest server generations — for simplicity purposes, we will call these servers "**type 1 through 4**" — looking specifically at two key efficiency metrics:

- **Megabits per second per watt** — a classic measure of power efficiency.
- **Megabits per second per watt per % CPU in use** — an enhanced metric factoring in CPU utilization, offering a clearer view of real-world efficiency under varying workloads.

Server Generations at a Glance

Each server generation was evaluated based on its technical specifications, including CPU type, core count, and network interface card (NIC).

Server Generation	Cores	NIC
Type 1	8	10 Gbps x 1
Type 2	20	100 Gbps x 2 Gen 1
Type 3	32	100 Gbps x 2 Gen 2
Type 4	48	100 Gbps x 2 Gen 3

Methodology: Capturing Peak Efficiency

To ensure robust results, we analyzed server performance during peak usage hours — 7 PM to 10 PM local time in their respective regions. Real-time data from our global data collection system and multiple metrics provided insights into power consumption and CPU activity.

Key adjustments

- **Type 1 power correction:** Type 1 servers report a single power value per chassis, which houses two servers. For accuracy, power consumption was halved per server.

Findings: Generational Efficiency Trends

Using the enhanced metric (megabits per second per watt per % CPU in use), our analysis revealed:

- **Efficiency Increases Across Generations:** Each new server generation consistently outperformed its predecessor, and our latest generation shows the highest efficiency values across both networks.

Encryption-Focused and Data Transfer-Optimized Insights

- **EF:** Servers demonstrated lower efficiency due to their cryptographic demands. However, even within this group, generational improvements were clear.
- **DTO:** Servers followed the same trend, benefiting from lower computational overhead.

Efficiency Gains at a Glance

Implications for Server Deployment

While Type 4 servers are the most efficient when fully utilized, idle cores still consume significant power. This highlights the importance of aligning workload allocation with available core capacity, especially for Type 4 servers, to optimize power usage.

Conclusion: A Clear Efficiency Progression

The study confirmed that Akamai's server generations have consistently increased in efficiency, with each iteration delivering significant improvements. **Type 4 servers** lead the fleet, underscoring Akamai's dedication to innovation and sustainability in powering the internet. However, future operational strategies should prioritize load balancing to maximize the potential of these cutting-edge servers.

This ongoing focus on efficiency reinforces Akamai's position as a leader in sustainable technology, ensuring our network meets the evolving demands of a connected world.

Sustainability-Focused Research and Design

Akamai has designed an ambitious new system that could enable customers to manage the electrical power used for them on our multi-tenant platform. Members of our Cloud Technology Group Architect team have been the force behind these designs, with the goal of supporting potential future features

around more environmentally friendly delivery, as customers help us prioritize further interest in this area.

The system, while in its early stages, is designed to enable customers to control the quality of the electrical power (e.g., in clean energy terms) used to power their end-user services and to specify when and how performance degradation would be acceptable to achieve it, if necessary. For example, a customer providing streaming video might prioritize using renewable energy while adjusting video quality or buffering times to save power. The technology is applicable to many services, such as streaming media, website delivery, and edge computing. Moreover, a tracking and reporting tool would enable customers to see the environmental impact their choices make and to demonstrate how their end-user services align with sustainability goals.

In December 2024, Akamai received a U.S. patent related to aspects of the work on this innovative project. The patent showcases Akamai's leadership in sustainable technology by embedding carbon-conscious choices into its platform.

The Future for Efficiency


Akamai is engaging in ongoing improvements for our infrastructure, focusing on innovative methods to enhance caching efficiency and resource optimization. By prioritizing corporate sustainability alongside operational excellence, Akamai demonstrates leadership in reducing emissions and setting a benchmark for green innovation in the technology sector.

This work highlights the significant role technology companies can play in global emissions reduction efforts, ensuring that the internet's growing demands do not come at the expense of the environment.

Supplier Engagement

Program Approach

At Akamai, we believe in delivering business results the right way. At our core, we value diversity, environmental consciousness, and social responsibility in all our business transactions. We work closely with our suppliers and partners to ensure their operations align with our corporate values. To this end, we collaborate with our suppliers to understand their approach to reducing their carbon footprint, promoting renewable energy, and enhancing overall facility efficiency. Our Sustainability team works closely with our data center, hardware, and network suppliers, advancing clean energy and reducing emissions.



Supplier Assessment Program

Responsible Supply Chain Program

To achieve our goal of working with accountable suppliers, we have created a Responsible Supply Chain Program (RSCP) that evaluates our suppliers based on their performance in areas such as the environment, labor and human rights, ethics, and sustainable procurement.

Our RSCP program has been designed to ensure that our suppliers adhere to responsible business practices and that we work together to promote sustainability across our supply chain. By implementing the RSCP, Akamai aims to foster a responsible and ethical supply chain that upholds our values and benefits for all of our stakeholders through:

- Aligning our suppliers to our ESG goals and values
- Minimizing risk and reputational impact
- Meeting customer expectations and requirements
- Preparing for supply chain regulations
- Strengthening supplier relationships and performance
- Meeting our 2030 sustainability goals

Collaborating with Data Center Vendors

Akamai's distributed network spans over 4,350+ locations worldwide, making collaboration with our colocation providers essential for tracking power consumption and understanding energy sources. We depend on these partners to supply detailed data on the power usage of our equipment and the proportion of energy sourced from renewable generation.

To measure progress toward our renewable energy and net-zero targets, we've implemented a multifaceted approach. Each year, we receive attestations from our colocation providers detailing the percent of renewable energy used at their facilities and the origins of that energy.

From a contractual standpoint, we have established a set of sustainability principles outlining clear requirements and expectations for suppliers to support our sustainability goals. These requirements are embedded in every stage of data center space and power procurement — from RFPs and requests for information (RFIs) to colocation agreements. This approach ensures consistent practices across all suppliers, regardless of their size or global location. It also allows us to devote more attention to discussions focused on opportunities with our partners that result in additional clean energy generation and acquisition.

We look forward to continuing to collaborate closely with our data center partners to help create a decarbonized internet infrastructure.

Industry Engagement

In 2024, Akamai worked with the [CEBA Colocation Working Group and Future of Internet Power](#) to help continue its mission to streamline and enhance clean energy procurement within the colocation data center sector. Key initiatives included:

- **Standardizing Emissions Reporting:** The group worked to [harmonize GHG accounting practices](#) among colocation providers and their customers, aiming to reduce inconsistencies and improve transparency in emissions reporting.
- **Advancing Renewable Energy Adoption:** Efforts were made to facilitate the integration of renewable energy sources into colocation facilities, supporting the broader decarbonization goals of the industry.
- **Educational Outreach:** The working group organized webinars and workshops to educate stakeholders on best practices in clean energy procurement and sustainability within colocation services.
- **Policy Advocacy:** Engaging with policymakers to advocate for regulations that support clean energy initiatives in the colocation sector was a priority, ensuring that legislative developments align with industry sustainability goals.


These efforts reflect CEBA's prioritization of fostering collaboration and driving progress toward a carbon-free energy future in the colocation data center industry. Akamai is proud to partner with CEBA in advancing this critical work, actively collaborating with colocation providers to align on best practices for emissions reporting, renewable energy integration, and sustainability initiatives. By working together, we aim to standardize approaches, enhance transparency, and unlock greater opportunities for decarbonization within the colocation sector, reinforcing our shared focus to a sustainable and climate-resilient future.

Circularity

Program Approach

Circularity is an essential concept for Akamai, as we are in pursuit of reducing our environmental impact and promoting sustainable practices globally. At its core, circularity refers to the idea that resources should be used to minimize waste and maximize efficiency while advancing our long-term sustainability goals and aspirations.

Through our circularity program under our 2030 sustainability goals, Akamai views the work that supports the program not just from a lens of our hardware operating cradle to grave. At Akamai, circularity is a holistic approach to support our goals through lifecycle management, best-in-class e-waste practices, customer and employee engagement, community, events, and public advocacy. Building a circular system is critical to the long-term success of our sustainability program and why it is featured as one of our 2030 goals.



E-Waste

Proper disposal of electronic waste (e-waste) is a pressing global concern. Today, the [Basel Convention](#) is the world's only legally binding agreement about waste. It prevents industrialized countries from dumping hazardous and household waste on developing countries. With the international importance of the Basel Convention, e-waste recycling is a priority for Akamai's global sustainability strategy. At Akamai, we follow the [Basel Action Network \(BAN\)](#) electronics stewardship known as the [e-Stewards Standard](#) to support a unified global approach to the Basel Convention.


Through our approach to circularity, we recycle 100% of our e-waste in compliance with all relevant environmental and security standards. At Akamai, we take a responsible approach to end-of-service hardware to ensure that our hardware is recycled in an environmentally sound way, and that any raw materials and potentially hazardous waste are handled with the utmost care.

To meet our goals, Akamai works with certified recyclers globally that adhere to the strict requirements of the e-Stewards Standard. Recyclers adhering to the standard are certified through annual audits that review their alignment to all international and local e-waste laws. The e-Stewards Certification is recognized by the [U.S. Environmental Protection Agency \(EPA\)](#) as an alternative standard to [Responsible Recycling \(R2\)](#).

E-Stewards Standard Guidelines for Enterprises

- **Secure data:** All stored data from all devices will be destroyed and will meet applicable destruction standards.
- **Responsible downstream management of all toxic materials:** Recyclers must track all toxic materials downstream of their facilities, account for them, and ensure proper management.
- **Legal and responsible exports:** Exports of toxic e-waste to developing countries are not allowed, in accordance with international law (Basel Convention).
- **Best recycling practices:** Managing toxic e-waste must be done in accordance with best available practices to protect workers and the environment.
- **Ethical labor:** No child, coerced, or prison labor is permitted.
- **Corporate-wide conformity:** Requires that all of the facilities and operations in each country belonging to a company are covered under the certification.

Lifecycle Management



Akamai partners with e-Stewards–certified recycling partners, such as premier partner [NCS Global](#), to provide critical lifecycle management services (LMS) for our global operations. The LMS process is a comprehensive approach that enables Akamai to manage our hardware assets throughout their entire lifecycle, building a critical component of circularity from acquisition to disposal.

By implementing LMS across Akamai's operations, we have maximized the value of our hardware assets and increased operational efficiencies in our deployments. One of the critical benefits of LMS is the ability to reuse and redeploy hardware assets that still have a useful life. Instead of disposing of hardware that no longer has a useful life, it is repurposed across our global infrastructure whenever possible. LMS continues to be a valuable tool for Akamai, as it significantly extends the lifespan of our hardware assets.

In addition to efficiencies, implementing LMS across Akamai's operational footprint has proven beneficial in the reliability of our deployed hardware. Akamai can make more informed decisions about when to retire or replace assets by having a comprehensive view of our hardware assets through LMS. This approach helps minimize platform downtime and reduce the risk of prolonged hardware failures.



With our partners like NCS, Akamai remains steadfast in our dedication to achieving our goals of circularity. We will continue exploring innovative ways to positively impact the recycling phases of renew and reuse, and inspire others to join us in this vital mission.

Water

Water is a critical resource in Akamai's supply chain, primarily used for cooling our networking equipment deployed globally. We recognize the importance of proactively assessing and mitigating our water-related impacts and risks and taking efforts to support water conservation globally.

With the exception of our global headquarters and two Akamai-Owned Data Centers (AODCs), Akamai's operations are primarily based in colocation spaces and leased offices. Our limited control in these environments has made it challenging to collect water consumption data and implement water efficiency measures. Despite this, we have used available data to identify our water-related risk exposure and indirect impacts and implemented efficiency programs at sites within our control.

Water Stress Assessment and Supplier Engagement

To assess our water-related risks, we employ the following approach:

- **WRI Aqueduct Tool:** We use the World Resources Institute (WRI) Aqueduct tool to monitor global water stress, particularly at network deployment locations. The tool helps us identify areas of high water stress and scarcity.
- **Annual Supplier Assessments:** We assess suppliers to gather data on cooling systems and water consumption at the site level, helping us to further understand local watershed risks.
- **Adaptive Management:** Based on the annual assessment results, we adapt our water management practices in our EMS to address identified risks. Sites and vendors with high water risk are prioritized for engagement and inclusion in our ISO 14001 audit process.

Although Akamai does not have full operational control over many of our network and office locations, we remain dedicated to working with our suppliers to evaluate water risks, prioritize water stewardship, and implement effective water efficiency and conservation practices. We encourage data center and office partners to adopt advanced cooling technologies — such as air, liquid, and hybrid systems — that minimize water consumption.

Water Efficiency Programs

At sites where Akamai has operational control, we prioritize sustainability and have implemented water efficiency programs. Our headquarters in Cambridge, Massachusetts, features an integrated water management system, including rainwater harvesting, which significantly reduces withdrawal from municipal water supplies. Both of our AODCs utilize free air cooling, taking advantage of the cool local climates.

Akamai Water Incubation and Acceleration Program

Akamai believes water conservation should be considered a necessity for today's existence and a proactive effort for the future. In line with this conviction, Akamai India's CSR Trust has taken proactive measures to address this critical challenge through their [Water Incubation and Acceleration Program](#) in partnership with the International Centre for Clean Water ([ICCW](#)). This initiative aims to support innovative organizations working toward solving India's water crisis by providing them with seed funding, mentorship, and other resources to help them build scalable and repeatable business models. Since the program's launch in 2020, Akamai has supported 30+ startups as part of this initiative.



We aspire to minimize our water footprint, safeguarding local water resources, and positively impacting the communities where we operate. We strive to avoid locations facing water scarcity to prevent exacerbating existing challenges. In areas with reliable water sources, we work to minimize our impact on local supplies and promote water conservation. We will continue to manage water-related impacts and risks through our EMS, evolving our practices for water data

Plastics

At Akamai, we're taking steps to reduce our reliance on plastic across our value chain. This initiative is part of our broader sustainability strategy to minimize environmental impact, especially at the end of our hardware's useful life. By identifying and analyzing the points across the lifecycle where plastics are used, we are better equipped to reduce, replace, or recycle these materials.

Although the use of plastics is crucial in Akamai's server and infrastructure deployments and data center operations, we are dedicated to exploring and incorporating sustainable practices and the use of alternatives when possible. Our direct control over the use of plastics in our operations is currently limited and mainly contingent on the manufacturing processes of the hardware and devices we employ. We continue to align on reducing our environmental footprint as viable mainstream alternatives continue to emerge.

It is also essential to note that Akamai does not directly manufacture products with plastics for consumer use. All of our services are virtual, providing much less plastic for direct consumer use, specifically in the security and network device appliance space.

Scope of Engagement

Our engagement in reducing plastics use includes:

- **Supplier engagement:** We collaborate with suppliers to understand the types and quantities of plastics used in our products and packaging.
- **Product design:** We consider the use of sustainable materials during the design phase of our products, aiming to reduce reliance on single-use plastics.
- **Lifecycle analysis:** We conduct lifecycle assessments to understand the environmental impact of plastics from production to disposal and identify opportunities for improvement.

Supplier Influence

At Akamai, we actively collaborate with our suppliers to reduce plastic waste, especially single-use plastics. We have optimized the packaging for our hardware, using materials other than plastics, such as recycled cardboard for padding, to minimize plastic use while ensuring the safe transport of our servers and hardware to their destinations.

In areas where Akamai can influence the use of plastic, we are working to implement sustainable practices that reduce plastic consumption where possible. Most plastic reduction efforts pertain to the suppliers of the products we procure and how we handle e-waste at the end of a product's useful life.

Our priority to work with suppliers and recycling 100% of our e-waste at the end of its helpful life demonstrates our responsible approach to waste and plastics management. We adhere to the e-Stewards Standard, which is globally recognized as the most rigorous for e-waste recycling. This approach ensures that our e-waste is handled responsibly, focusing on protecting human health and the environment. By adhering to the e-Stewards Standard, Akamai ensures that our e-waste recycling processes, including the processes directly related to the recycling of plastics, are ethical and environmentally sound.

Customer Engagement

As a leader of the modern internet, Akamai plays an enormous role in the climate transition. Each year, more customers look to Akamai to help steward their sustainability journey. Our industry-leading emissions reporting helps customers navigate everything from complex regulatory requirements to sustainability priorities set by their board of directors. We empower customers to tell their story with a unique level of data specificity that is unmatched in the industry. As the regulatory landscape continues to evolve, even more customers will be required to disclose their emissions in the coming years. New regulations in Europe and the U.S. have further underscored the importance of this work and highlighted the need to build capacity beyond the Akamai Corporate Sustainability team itself.

Sales Enablement Program

In preparation, Akamai is dedicating even more time and resources to scaling our sustainability program. In 2024, we kicked off a listening and learning journey to better understand how we could be the best possible partners for our customers when it comes to their environmental needs. We first met with customers and employees in EMEA to understand the contours of the conversation. We then used this feedback to launch an enablement program that will equip our Sales teams with the tools and skills to weave sustainability into every customer interaction.



With the program now launched, we look forward to continuing this journey in other regions to better understand how the conversation varies by geography. We seek to continuously improve our understanding of customer needs and meet them with thoughtful solutions and support.


Akamai Carbon Calculator

A key part of this effort is equipping our customers with the data to tell their unique sustainability stories. Many Akamai customers share our focus on reducing emissions, including those generated by their IT suppliers. That's why we created the Carbon Calculator, a tool that shows an estimated calculation of the emissions produced by an individual customer's actual use of Akamai delivery and security services.

Integrated into the Akamai Control Center, the Carbon Calculator provides an estimate of the emissions associated with a specific subset of customer traffic from the past 48 hours to a period of up to 400 days. Customers can see at a glance the total bytes delivered and the calculated emissions in grams, kilograms, and metric tonnes (m tonnes) of carbon dioxide equivalency (CO₂e) for a given date range. The information reported by the calculator also provides a view of estimated emissions by country, color-coded by the volume of bytes and emissions, from low to high.

The Carbon Calculator is an innovative tool designed to keep Akamai customers informed and engaged on the issue of emissions reduction, reflecting our ongoing focus on sustainability.

With our advanced measurement approach and more user-focused strategy, our carbon emissions calculator will be a practical tool for customers who seek to understand and ultimately reduce their carbon footprint related to their use of our global platform.


Custom Emissions Reporting

Sustainability Advocacy

Akamai has actively advocated for public policies that align with our long-term sustainability goals and corporate values, particularly those aimed at clean energy, grid reliability, and climate accountability. As

the company that powers and protects life online, Akamai recognizes that well-structured policies can support our operational sustainability and foster a favorable business environment that encourages broader economic growth and environmental stewardship. This engagement directly supports Akamai's 2030 goals of achieving 100% renewable energy, reducing carbon emissions to net zero, and promoting circular economy practices across our facilities and data centers.

Strategic Importance of Public Policy in Akamai's Sustainability Framework

Through our efforts, Akamai demonstrates a proactive approach to public policy engagement that directly supports our sustainability goals by:

- **Enhancing Renewable Energy Access:** Policies supporting renewable energy deployment directly enable Akamai's 100% renewable energy goal.
- **Reducing Carbon Emissions:** Participation in the Regional Greenhouse Gas Initiative (RGGI) and supporting energy efficiency legislation aligns with Akamai's targets for emissions reduction.
- **Strengthening Grid Reliability:** By promoting grid modernization and reliability standards, Akamai helps ensure a resilient energy infrastructure, essential for sustainable operations.
- **Economic and Community Development:** Advocacy for inclusivity in workforce development and climate technology investments underlines Akamai's dedication to social responsibility and sustainable development for all.

Akamai's robust support for clean energy policy signifies our belief that effective public policy is crucial for meeting our global climate goals and achieving a sustainable business model that benefits both the environment and the economy.

Key Legislative Actions Supported by Akamai in 2024

Massachusetts Climate and Economic Development Package

Akamai joined a coalition of businesses to support Massachusetts' H.4459, the "Mass Leads Act," advocating for strategic investments in climate tech and clean energy industries within the state. This act aims to position Massachusetts as a global hub for climate tech, aligning with Akamai's goal to drive a clean energy transition and stimulate job creation. Akamai endorsed key components, including:

- **Investment in MassCEC:** Funding for the Massachusetts Clean Energy Center to strengthen its role in supporting innovation and workforce development in the green economy.
- **Green Workforce Development:** Programs to grow a skilled workforce for decarbonization, focusing on inclusive training that reaches marginalized communities disproportionately impacted by climate change.

California's Climate Disclosure Legislation (SB 253 and SB 261)

Akamai supported full funding for California's climate disclosure mandates, SB 253 and SB 261, to ensure timely implementation of corporate climate accountability. The alignment of California's standards with frameworks like the TCFD and current GHGP mirrors Akamai's focus on transparent, standardized and impactful emissions reporting. As part of a coalition, Akamai emphasized that these

laws will provide reliable climate-related risk data, helping companies, investors, and the public make informed decisions.

Virginia's Participation in the Regional Greenhouse Gas Initiative (RGGI)

Akamai backed Virginia's continued participation in the RGGI, a regional cap-and-trade program. The RGGI has brought more than \$820 million to Virginia, used to fund energy efficiency projects and flood resilience. Akamai's advocacy underscores the role of market-based solutions in reducing carbon pollution, supporting our long-term aspiration of a low-carbon economy.

Support for Grid Reliability in California (AB 2368)

California's AB 2368 focuses on improving grid reliability, especially critical as the state faces power shortages due to extreme weather. Akamai's support for this legislation reflects our need for a stable energy grid to achieve net-zero goals, reduce dependence on fossil fuels, and maintain sustainable business operations. AB 2368's framework aligns with Akamai's focus on building a resilient infrastructure that can adapt to climate impacts.

Southeast Grid Modernization and Economic Growth Initiatives

Akamai joined other energy customers in the Southeast to advocate for grid modernization policies across North Carolina, South Carolina, and Georgia. The recommendations include leveraging federal incentives for clean energy deployment, updating transmission lines, and supporting voluntary investments in renewables. Akamai's involvement emphasizes our dedication to grid modernization as a necessary step toward achieving energy efficiency and meeting the growing electricity demand while supporting the low-carbon transition.

Virginia SAVE Act for Energy Efficiency

In Virginia, Akamai supported the Savings Achieved Via Efficiency (SAVE) Act to establish binding energy efficiency standards. This act is expected to help large energy consumers, like Akamai, lower operational costs, increase resilience, and reduce carbon emissions through utility-driven efficiency programs. The act aligns with Akamai's sustainability framework, driving resource efficiency and cost savings as the company advances our sustainability goals.

Virginia Legislative Briefing at AES Spotsylvania Solar

In August 2024, [Akamai co-hosted a site visit to the AES Spotsylvania Solar facility](#) in Virginia, the largest solar project east of the Rockies. This event provided policymakers, businesses, and local chambers with an in-depth look at the facility's operations, including its active substation, integrated sheep grazing for vegetation management, and the expansive Highlander solar array. The visit facilitated discussions on the benefits of renewable energy deployment in the Commonwealth and strategies to attract new economic opportunities across Virginia.

Akamai's involvement in this initiative underscores our goal to advancing renewable energy and engaging with stakeholders to promote sustainable practices. By showcasing the practical applications and economic advantages of large-scale solar projects, Akamai aims to inspire policy decisions that align with our 2030 sustainability goals, including achieving 100% renewable energy usage and reducing carbon emissions. This engagement reflects Akamai's dedication to fostering collaborative efforts that drive the transition to a low-carbon economy.

Pennsylvania Renewable Energy and Sustainability Support (PRESS) Legislation

Akamai joined other businesses in supporting Pennsylvania's PRESS legislation, which aims to advance clean energy, foster sustainability, and drive economic growth in the state. This legislation aligns with Akamai's goals of achieving 100% renewable energy and reducing emissions by 2030. Key elements Akamai endorses include:

- **Clean Energy Infrastructure:** PRESS will fund renewable energy projects, making Pennsylvania a regional leader in clean energy and reducing dependence on fossil fuels.
- **Sustainability Innovation Hub:** PRESS proposes a hub to bring together businesses, universities, and government to drive sustainability innovation — an initiative aligned with Akamai's focus on collaborative, climate-focused solutions.
- **Workforce Development:** PRESS will support training programs to build a skilled workforce in renewable energy, with a focus on including marginalized communities.
- **Corporate Renewable Energy Incentives:** The legislation offers incentives for companies to adopt renewable energy, helping businesses lower operational emissions and supporting sustainable growth.

As we look toward 2030, Akamai's strategic partnerships and policy endorsements reinforce our goals to not only adapt to but also shape a sustainable future.

Clean Energy Demand Initiative

[The Clean Energy Demand Initiative \(CEDI\)](#) is a collaborative platform established by the U.S. Department of State to unite corporations and countries in advancing clean energy goals. Launched during COP26, CEDI facilitates partnerships where companies express demand for renewable energy, and countries develop policies to attract clean energy investments. This initiative aims to accelerate the global transition to a low-carbon economy by leveraging corporate priorities to drive the deployment of clean energy infrastructure.

Akamai engaged with CEBA and CEDI in a series of strategic meetings with delegations from Japan, Vietnam, India, and Indonesia. These discussions aimed to advance clean energy policies and programs, fostering collaboration between corporate energy buyers and national governments to accelerate the transition to renewable energy sources.



International Policy Engagements During 2024

- **Japan:** During Climate Week NYC 2024, Akamai participated in a roundtable meeting with Japanese officials to discuss enhancing the country's renewable energy infrastructure. The dialogue focused on policy frameworks that support corporate clean energy procurement, with the goal of attracting significant investment from multinational companies that prioritize sustainability.
- **Vietnam:** During 2024, Akamai engaged with CEBA and CEDI representatives to meet with Vietnamese officials to discuss enhancing the country's renewable energy infrastructure.

Similarly to Japan, The dialogue focused on policy frameworks that support corporate clean energy procurement, with the goal of attracting significant investment from multinational companies that prioritize sustainability.

- **India:** During Climate Week NYC 2024, Akamai participated in a roundtable with Indian delegates, with an emphasis on scaling up renewable energy projects to meet the country's ambitious climate goals. Discussions included strategies for streamlining regulatory processes and creating incentives for private sector participation in the clean energy sector.
- **Indonesia:** In 2024, Akamai engaged through CEDI with Indonesian officials, centered on overcoming barriers to renewable energy adoption. The parties explored opportunities for public-private partnerships to develop sustainable energy projects, leveraging corporate demand to drive policy reforms and infrastructure development.

Role of CEDI

The U.S. Department of State, through CEDI, plays a pivotal role in facilitating these collaborations. By bringing together corporate energy buyers and national governments, CEDI aims to create enabling environments for clean energy investments. This approach not only supports the renewable energy goals of corporations but also assists countries in achieving their climate objectives by attracting private sector investment and expertise.

These engagements underscore the importance of international cooperation in advancing clean energy initiatives. By aligning corporate sustainability goals with national policy frameworks, such collaborations aim to accelerate the global transition to a low-carbon economy.


Advancing Our Sustainability Priorities

Our Environmental Management System

Our global environmental management system (EMS) reflects our unwavering focus on excellence and continuous improvement in our sustainability program. Serving as the backbone of our environmental strategy, the EMS integrates our sustainability goals with a comprehensive approach to managing environmental impacts and risks, addressing stakeholder needs, enabling transparent measurement and reporting, guiding leadership and governance, promoting operational best practices, identifying opportunities for improvement, and driving sustainability projects and programs.



Our EMS has been independently verified as compliant with the ISO 14001:2015 standard. To meet and exceed the standard's requirements, we have developed robust internal systems for tracking, monitoring, measuring, and reporting, tailored to Akamai's unique operations and designed to support the continuous evolution of our EMS. These tools empower teams across the company to collaboratively drive progress toward environmental objectives while delivering transparency and actionable insights into the company's environmental performance.



The scope of our EMS covers environmental management of Akamai's operational efficiency lifecycle, including strategy & architecture, implementation, operational improvement, and end of service — across data center and office facilities, physical hardware, software, network, capacity, and value chain contributing to greenhouse gas emissions output across scope 1, 2, and 3. This includes areas beyond our direct operational control and encompasses all of Akamai's global activities across our value chain.

Developing our EMS in compliance with ISO 14001 was a complex endeavor. Although the ISO standard is designed for application by any organization, we encountered unique challenges given our focus on building, delivering, and securing digital experiences rather than physical goods. To overcome these challenges and build an efficient EMS, we leveraged creativity and innovation to create a system that comprehensively addresses our environmental impact.

The independent audit process for attestation involved thorough evaluations of our EMS processes and site audits to verify EMS effectiveness from our headquarters to the edge. This multiyear effort led to significant improvements and culminated in our initial statement of attestation in 2024. Going forward, we will continue to undergo an annual independent audit process to maintain our ISO 14001 compliance and attestation. Within the framework of the ISO 14001 standard and the ongoing compliance audit process, we continue to challenge the status quo, using pioneering approaches to uncover and address continuous improvement opportunities across the full scope of our EMS.

Our work doesn't end here. Building a robust EMS is challenging but necessary to pursue our goals rigorously. We are prioritizing the continual improvement of our EMS and reducing our environmental footprint across our global platform. We actively seek opportunities to collaborate with internal and

external partners to empower sustainable improvements and deliver on Akamai's sustainability mission of harnessing the power of our global platform to create a sustainable and equitable future for the world.

Sustainability Training

As sustainability becomes an even bigger part of the global conversation, we have prioritized listening to and learning from our customers and employees to better understand how we can support them on this journey. We spent 2024 collecting an initial round of feedback, and used that information to build and launch two training modules to empower Akamai employees to drive sustainability deeper into the business in 2025 and beyond.

Sustainability Essentials

This module grounds the learner in foundational sustainability concepts and empowers them to engage directly in Akamai's sustainability work.

Communicating Akamai's sustainability strategy in a way that is clear, approachable, and directly connected to our everyday lives allows us to meet our colleagues where they are. The module invites all employees to participate in Akamai's climate journey by submitting continuous improvement ideas, reporting nonconformities, and raising awareness. This training is required annually for all employees and is a vital part of maintaining our ISO 14001 attestation.



Sustainability Stewardship



This voluntary companion module builds on the Essentials course and was developed in collaboration with sustainability champions within the Sales organization. It empowers Akamai Sales teams to bring customers deeper into the discussion by providing the tools and structure to lead sustainability conversations at every stage of the sales cycle. Learners are encouraged to discover their customers' unique needs and challenges with regard to their sustainability journey, and meet them where they are with tailored data and guidance.

Climate Governance

Akamai has aligned on maintaining strong climate governance structures that ensure accountability, drive sustainability initiatives, and align with global best practices. A key element of this governance

approach has been focused on adhering to the recommendations of the TCFD, which has served as a foundation for our climate-related reporting and risk management strategies. With the announcement in 2023 that the TCFD would be evolving into the IFRS S1 and S2 standards, we are actively planning for the future.

Integrating the ISSB Disclosure

Akamai recognizes the recent shift toward the International Sustainability Standards Board (ISSB) disclosures, specifically IFRS S1 and S2. These standards, building on TCFD's foundational principles, represent a new benchmark for corporate sustainability reporting that we are preparing to adopt in the future.

As we plan our transition from TCFD to the IFRS standards, this signifies Akamai's readiness to adapt to evolving best practices in climate and sustainability governance. By supporting an ISSB-aligned disclosure, Akamai will continue to uphold transparency and accountability, leveraging the comprehensive guidance of IFRS S1 and S2 to enhance our climate and sustainability reporting. This shift aligns with Akamai's dedication to responsible corporate governance and underscores our focus on building a resilient, sustainable future for our business and stakeholders.

Akamai's Governance and Transparency Efforts

The TCFD framework has provided a structured approach for companies to disclose climate-related risks and opportunities, covering governance, strategy, risk management, and metrics. Akamai aligned with TCFD to strengthen our climate governance in several ways, and we feel this will be translatable to the IFRS S1 and S2 when we transition.

Transparency in Climate-Related Risk and Strategy

Adopting TCFD standards allows Akamai to transparently communicate how we assess and manage climate-related risks, enhancing trust among stakeholders. By disclosing both physical risks (e.g., extreme weather events affecting infrastructure) and transitional risks (e.g., policy shifts toward lower carbon), Akamai demonstrates how climate considerations are embedded in our long-term strategic planning and operational resilience.

Accountability Through Defined Governance Structure

Under TCFD guidance, Akamai has established clear oversight responsibilities within our board and executive leadership for climate-related decisions. Regular reviews ensure that climate considerations are integrated into overall business risk assessments, and specific accountability channels are set up to monitor progress against our climate goals. This governance structure also enables Akamai to identify emerging risks and respond proactively, further reinforcing our dedication to responsible corporate governance.

Enhancing Investor Confidence and Meeting Regulatory Expectations

With growing global regulatory interest in climate-related disclosures, TCFD compliance positions Akamai favorably in both U.S. and international markets. Investors increasingly seek robust climate governance as a marker of a sustainable, future-focused company. By aligning with TCFD, Akamai not only meets investor expectations but also anticipates forthcoming regulatory requirements, including the EU Corporate Sustainability Reporting Directive (CSRD) and similar U.S. and global mandates.

Driving Long-Term Value and Stakeholder Trust

Transparent climate governance is integral to sustaining long-term value. Through our TCFD-compliant disclosures, Akamai continues to reinforce our priority to address climate change responsibly, which resonates with customers, employees, and communities. By proactively addressing climate risks and reporting progress in line with TCFD, it has helped Akamai to foster stakeholder trust, which we believe is crucial for ongoing business resilience and success.

Continuous Improvement

The TCFD framework is a strategic tool that has enabled Akamai to continually assess and enhance our climate governance. As Akamai prepares for the IFRS S1 and S2 transition, we reaffirm our alignment with the latest global standards, supporting our mission of robust climate governance and transparency. This evolution reflects our leadership in sustainability and readiness to meet the changing needs of investors, regulators, and the global community.
